

LEAGUE OF WOMEN VOTERS OF ATLANTA RECORDS, 1920 - 1963 and undated. Primarily original loose papers; some printed material; photocopies of original and printed material; 10 photographs; 1 audio tape. 661 folders, 3 oversize folders; 30 boxes.

Donors: League of Women Voters of Atlanta; Lethea Turman Lochridge; Mrs. C.T. Owen.

The League of Women Voters of Atlanta was organized in 1920, one month before the establishment of the National League of Women Voters, later called the League of Women Voters of the U.S. The Atlanta League was initially called the Atlanta League of Woman Citizens. It was founded after the August 1920 ratification of the woman suffrage amendment by many of the same women who were active in the Central Committee of Woman Citizens, an organization established in 1919 to administer the registration of women to vote in the 1919 Atlanta municipal election.

The purpose of the League of Women Voters of Atlanta, a non-partisan organization, was to obtain better government through an informed public. Because women were not granted suffrage in this country until 1920 (except for cases such as the 1919 Atlanta municipal election and other local or state exceptions), many women approached their recent franchisement with a conscientious attitude. The ex-suffragists of 1920 who joined the League of Women Voters of Atlanta not only exercised their right to vote. They were also active in the voter registration of other women; the study of citizenship, city government and politics; research and massive publicity on voting issues, candidates, voting and registration official procedures; and the involvement of Atlanta civic and business leaders in their work.

Eleanore Raoul [Mrs. Harry L. Greene] was the primary driving force behind the effective administration of the Atlanta League. She also appears to be responsible for much of the documentary information in the records (early minutes, correspondence, and compilations about League work). She was involved in suffrage work in Georgia, New Jersey, New York, and West Virginia beginning in 1915. She was also a paid worker for the National Suffrage office in New York for a time. Miss Raoul headed the Central Committee of Woman Citizens in Atlanta and was most active in setting up the administration and functional reorganization of the Atlanta League. She also found time to study law and graduated from Emory Law School in the early 1920's. By the 1930's, she moved out of elected positions in the Atlanta League, largely because of her trust in the leadership abilities of other members. She recognized that an organization operated primarily through one major leader tended to thwart the capacities of other potential leaders.

Another active leader in the Atlanta League was Maude Pollard Turman, who served several terms as President and Board Chairman in the 1920's and 1930's. She was at one time director of the National League; she also taught a citizenship course at Emory University based on her book *Lessons in Citizenship*. She and Miss Raoul founded the organization Active Voters.

The Atlanta League was governed by a board elected by the entire membership which was responsible for determining official policies. It appointed a director or executive head responsible for staff which carried out the policies. The League Program was adopted by a vote of the entire membership at the annual meetings (usually held in January). Only items which

were studied for one year could be sponsored by the League as a project. The Atlanta League attended public meetings and maintained contact with public officials concerning local political issues, sponsored study groups on citizenship and special issues, published a monthly bulletin *Facts* and other publications, sponsored public forums, and conducted other non-partisan activities on the investigation of local government. A 1944 report stated that this was the "first time a group of citizens has carefully followed the activities of public officials with no ulterior or selfish motive."

The Atlanta League was financed through membership dues (part of which went to the Georgia League) and contributions. Early League finance activities were primarily focused on increasing membership and soliciting contributions from members. By the 1940's the finance committee implemented quite sophisticated finance drives focusing on the financial support of major Atlanta business leaders. The Atlanta League also encouraged these leaders to publicize and support the registration and voting of their employees.

To encourage wider membership and support, the Men's Council of the Atlanta League was established in 1929, composed of Atlanta civic and business leaders. A Men's Finance Luncheon was usually held as a part of the Annual Meetings. Records concerning the Men's Council are located with the Board Minutes of 1929, the Finance Committee records, and the Annual Meeting Minutes, especially for 1934 and 1937.

A Business Women's group was also established as part of the Atlanta League to facilitate membership by a wider spectrum of women. Reports of this group were submitted at the board meetings.

These records document both the work of the League's internal administration -- its organization, finance, membership, publicity; and its activity in numerous local government improvement campaigns. The first major campaign of the Atlanta League was for the revision of the city charter, a voting issue in 1922 and 1927. A Citizen's Charter Committee was established for the 1922 campaign for a Council-Manager system of city government. The League also sponsored lectures by Dr. A.R. Hatton, an authority on city government during this time.

In 1924, the Atlanta League began conducting major voter registration campaigns; by 1926, these were complemented by active "Get out the Vote" campaigns in which the League obtained the support of other civic groups. Board Minutes as early as 1921 document the League's work in conducting Citizenship Schools to meet the public need for information on public issues and the operation of city government. League members also spoke to civic and school groups on city government and the League work. The Atlanta League also conducted candidates meetings and initiated a candidate's questionnaire about the candidates' personal history and stance on specific issues. This and other information was published in the monthly publication *Facts*, which was begun in 1928. The February issue was a political directory which cited the names, functions, and salaries of public officials and of members of numerous city and county boards or commissions.

The records are an invaluable source for the study of the Atlanta League, the role of women in voluntary organizations, the study of Atlanta politics and government, and the impact of the ratification of the Woman Suffrage Amendment. Of particular interest are the names of those Atlanta citizens (League members and other civic and business leaders) who were so actively

involved with the improvement of Atlanta city government. Also of interest are the investigative files on candidates and elections and the subject files on the 1930's graft investigation in the Atlanta city government. The records document the Atlanta League's affiliation with state and national Leagues and include significant broadsides and other printed material on voting and public issues.

The records are arranged in the 18 series. Folders within each series bear both the series number and folder number.

Series 1. Minutes, 1920 - 1956, 1960, 81 folders

This series consists of the minutes and other papers documenting the proceedings of the Executive Board meetings and of the Annual (and often Semi-Annual and Quarterly) meetings. The governing board of the Atlanta League was initially called the Central Committee of the League of Women Voters. By 1922, it was called the Executive Board, and later, the Board of Directors. Most often, these minutes are called Board Minutes. Board meetings were usually held monthly, except for occasional especially-called meetings. They were attended by officers of the League including elected officers, ward chairmen, and committee chairmen. Some Board Minutes record the attendance of board members. Also filed with these minutes are agendas; monthly reports of the League office, the treasurer, ward organizations, membership committee and other committees; resolutions passed by the board; some correspondence about meetings; and in a few cases, records about publicity and speakers' bureau schedules. See also the records of specific committees.

1920 Board Minutes indicate that most of the work of the League was being done through the wards, corresponding to the twelve municipal voting districts (wards) within Atlanta. The Officers' Committee of the Atlanta League was composed of representative ward leaders from each of these wards. The only extant minutes of the Officers' Committee meetings are for the years 1942, 1946, 1947, and 1953. As the committee was apparently a part of the Board, the Officers' Committee Minutes are filed after the Board Minutes for those years. See also the records of the Ward Officers' Council, 1927 - 1928 and Ward Registration and Canvas Records, 1921 - 1932 in Series 5.

Annual meetings were usually held in January, attended by the general membership. During the Annual meetings, annual reports of the officers, committees, and ward leaders were presented. These reports, and related correspondence, and records of proceedings of the meetings are included with these records.

From 1921 - 1928, Quarterly meetings were held; the first Quarterly meeting was often the well-attended Annual meeting. There are often much briefer accounts of the later Quarterly (and some Semi-Annual) meetings.

Series 2. Treasurer's Records, 1921 - 1929, 17 folders.

The records of the Treasurer, an elected officer, document numerous functions performed by the Atlanta League. They are directly related to records created or held by the Finance Committee. As there appears to be no other membership lists for the early years except for the Treasurer's Membership/Donation Books in this series, it is possible that the Membership Committee and the Treasurer operated from this one set of records. Later records of the Treasurer can be found with the records of the Finance Committee, Series 3; the Finance Committee members apparently used records both of the Treasurer and the Membership Committee in their work, and filed them with the records of their committee.

The records in this series consist of Financial Journals and Ledgers, one bank account book, and Treasurer's Membership/Donation Books. The Treasurer also made monthly Treasurer's Reports at the Board meetings which are located in Series 1.

Entries in the Financial Journals in this series are arranged monthly recording categories of receipts and disbursements. Beside each entry of a receipt or disbursement is a page number which refers to that entry in the Financial Ledger.

Entries in the Financial Ledgers are arranged by categories of receipts and disbursements recording monthly amounts. Both the Journals and the Ledgers were kept by the Treasurer.

The Treasurer's Membership/Donation Books record the following on a monthly basis: name of member, address, ward, and amount of dues paid. They also record monthly donations citing name, address, and amount. In some books, the record of donations begins at the back of the book, moving chronologically toward the center of the book. From these records, lists of members and donors were compiled citing address and amount of donations or dues paid over a several year span. Based on these lists, the Finance Committee appealed to past donors or unpaid members for continued financial support.

Also included in this series is a Bank Account Book of the Atlanta League with the Central Bank and Trust "Ladies Department" recording deposits.

Series 3. Finance Committee Records, 1920 - 1958 and undated, 61 folders.

The Finance Committee was active in obtaining financial support for the work of the Atlanta League. Massive lists of League members, contributors, and prospective donors were compiled. These recorded names, addresses, phone numbers, amount of last donation or dues paid, and in some cases remarks about letters to write or visits to make. Often, these are arranged by men donors and by women donors, and by wards.

The Finance Committee apparently worked closely with the Membership Committee. League members were contacted by the Finance Committee concerning paying of dues and in some cases, contributions. The committee also wrote and visited Atlanta business and civic leaders acquainting them with the work of the League, inviting them to join, and encouraging them to make a donation. In 1927, a Men's Council to the League was organized in order to obtain financial and other support from a wider sector of Atlanta citizens. Finance Luncheons held during the Annual meetings were a vehicle by which the League obtained pledges for financial support during the year. By 1946, the Atlanta League was obtaining \$750 pledges from representatives of several major Atlanta companies at the Men's Council Finance Luncheons.

The Finance Committee records consist of lists of donors, lists of members, correspondence, and other records concerning finance plans. The only extant minutes of the committee are for the years 1927 - 1930, and 1934. In some cases, annual budget sheets are included for reference by the Committee. However, as annual budgets were passed at the Annual meetings, most budget records are located with the Annual Meetings Minutes in Series 1. See also Series 17, folder 4, National League publications concerning finance planning.

Series 4. Membership Committee Records, 1920 - 1927, 1938 - 1954, 6 folders.

Membership lists of the Atlanta League were apparently used by the Finance Committee in the solicitation of dues from members, and were kept in their files. See also Series 3, Finance Committee Records. Finance files entitled "Donor Lists" include also some membership lists. Membership Committee reports were submitted monthly at the Board meetings. See also Series 1, Minutes.

This series consists of Membership Committee records which were not filed with other series by the League. They include outgoing letters concerning renewal of annual memberships or new memberships, and alphabetical membership lists citing name, address, phone number, number of years of membership, and dues due date. The outgoing letters concerning membership renewals often contain information on other League functions.

Series 5. Ward Records, 1921 - 1932 and undated, 14 folders.

Each ward leader or ward officer was a member of a governing committee known by several names. During 1927 - 1928, the committee was called the "Ward Officers' Council." However, during 1925 - 1928, the ward leaders were affiliated with the "Organization Committee" whose chairman corresponded with ward leaders concerning the structure of the ward organization. The ward organizations were created to canvass the residents of their ward for new League members and to encourage the registration of women in the wards to vote. The canvass records in this series contain names, addresses, and some comments of women canvassed. After ca. 1930, most of the canvassing for League membership and registration was done through a central Atlanta League office instead of through ward organizations.

The records in this series include monthly reports, some canvass and registration records, some ward meeting minutes, and other records documenting the work of the Atlanta League on the ward level of organization. See also Officers' Committee Minutes located in Series 1.

Series 6. Registration Campaign and "Get out the Vote" Campaign Records, 1924 – 1944 and undated, 18 folders.

The records in this series reflect the Atlanta League's activity in voter registration and publicity about voting. There is no indication that the voter registration drives were focused upon the registration of Blacks or other minorities. The primary focus was initially upon the registration of women. Later, the drives emphasized the registration and voting of the general populace of the city of Atlanta.

Massive voter registration drives were conducted by the Atlanta League during 1924 - 1927 based on the idea of a "portable registration booth." These records include schedules citing locations and dates/times for the roving registration truck staffed by Atlanta League members. By the 1940's, the League contacted various major employers and numerous civic groups seeking their commitment to assist the League in the registration of employees and group members. Also included is information on city and state voter registration laws.

The "Get Out The Vote" campaigns were begun in 1926 and were closely aligned with the voter registration drives. Numerous civic groups including the Chamber of Commerce and professional organizations cooperated with the League in these campaigns. In 1926, the Georgia League of Women Voters sponsored a Voters' Prize for the city which increased their voting by the largest percentage. The Fifth Ward of Atlanta won the prize. Information on the Voters' Prize is included with the "Get Out The Vote" records. Included are "Get Out The Vote" Committee minutes, correspondence, publicity, and other records.

At various times in the Atlanta League's history, attempts were made to meet the "need in Atlanta for an organization...[to] use the League's non-partisan information as a background for partisan leadership..." (See folder 3, letter of November 15, 1938.)

In 1933, a Candidates Committee composed of League members, Men's Council members, and other civic group members was formed as an organization "to develop civic leadership and attract a high type of citizen to public office." Studies of local government were conducted citing needs to be fulfilled by candidates for specified public offices. Hopefully, the candidates running for local offices would address the needs as assessed by this committee.

By 1938, a Citizens Committee was formed to perform a similar function. Correspondence refers to the fact that the Candidates Committee of 1933 - 1934 was not a success. Early plans of the Citizens Committee were to prepare a uniform questionnaire for candidates. Though the records do not indicate the success or failure of the 1938 - 1939 committee, Election Files in Series 12 contain some candidates questionnaires to be returned to the Atlanta League as early as 1938.

The records in this series consist of some minutes or notes on meetings. Also included are reference publications about similar committees throughout the country, correspondence, and names of committee members.

Series 8. Citizenship Training Records, 1927 - 1950 and undated, 5 folders.

As early as 1921, League Board Minutes refer to conducting a citizenship school to inform citizens about the operation of city government, regulations about registration and voting, and about candidates.

This series consists of records documenting the League's training courses on Atlanta city government, state and national government, voter registration, the city Democratic Executive Committee, and on specific issues such as taxes, welfare, and labor. Included are course outlines (featuring a trip to City Hall), schedules of class speakers, and texts of lectures. See also Series 1, Minutes, where annual and monthly reports were often submitted under the headings "Citizenship Training" or "Political Highlights." See also Annual Meeting Minutes which include reports of the Men's Council which was also active in citizenship training. Series 10, Publicity, folders 22 - 26 contain texts of radio scripts on citizenship. Series 11, Subject Files, folder 9 contains information on the citizenship training program on post-war foreign policy.
